- (d) Lead and coordinate the management of performance data across the Secretariat to establish streamlined data collection, analysis, quality monitoring which ensures cohesive and innovative reporting on organizational performance (KPIs, thematic, SDGs contributions, compliance to technical regulations, etc.) and informs Members, UN, partners and public;
- (e) Advise Executive Management and inform constituent bodies (Congress, Executive Council, the EC Policy Advisory Committee and others) on progress in implementation of the Strategic and Operating Plans and contribute with performance analysis, trends, patterns and potential risks;
